

## PUBLIC ANNOUNCEMENT

The ban imposed on new natural gas domestic connections by Government of Pakistan is still in place. However, relaxation is allowed for **Private Housing Societies through RLNG-Based Domestic Connections**; therefore, SSGC has started receiving applications for new gas connections. Applicants desirous of New RLNG based Domestic Gas Connections in Karachi may submit their applications directly with Sales Department, Head Office near Civic Center, Gulshan e Iqbal Karachi. Applicants other than Karachi may submit their applications with their respective SSGC Regional/Zonal Offices.

- Approved Plan / Letter, Drawing and Completion Certificate.
